



#### Pense Flyers Hockey



Hello Pense Progress,

First of all, let me introduce myself to you; my name is Monica L. Brown, I'm a Specialist in the US Forces, Afghanistan. I got your email address from a directory on the internet here in Afghanistan, so I pray that you receive my email and reply back to me soon. I know you don't know me but I meant no harm sending you this note, just that I don't have anyone out there to talk to as I lost my parents in a car accident when I was 9 years old. I was raised by my adopted parents, but they died some years ago, the relatives of my adopted parents threw me out of the house saying that I was not their real daughter. You may be wondering why I chose to entrust a delicate matter like this to the care of a stranger, but this is the best I can do in my present situation. I would have trusted this kind of project in the hands of my only brother, but he has ruined his life with hard drugs, hence my decision to work with a neutral person if we can establish some trust between ourselves. instead of me confiding in my buddies back home so that this little secret can be preserved.

I and some other officers made some deals on the oil business over there in Iraq before my exit to Afghanistan. The deal was worth \$186 Million US Dollars and after we have all shared the money, I later realized Nine Million, Three Hundred Thousand US Dollars (\$9,300,000.00 USD) which is my personal share of the deal. Due to my status as a US Specialist, I can't move this huge fund to my account in the United States in order to avoid further interrogation or face any kind of probation by the U.S government. I believe that such opportunities only come one's way once in a lifetime; I cannot let this chance pass me by. For once I find myself in total control of my destiny, so this chance won't pass me by. I ask that you do not destroy my chance, if you will not work with me, just let me know and I will move on with my life but do not destroy me. If you give me positive signals, I will give you the relevant details and initiate this process towards a conclusion. I send you this email not without a measure of fear as to what the consequences are, but I know within me that nothing ventured is nothing gained and that success and riches never come easy or on a platter of gold. Do not betray my confidence, if you wish to proceed with this, please get back to me.


#### Dear Sgt. Monica L Brown,

I am glad you found solace in your career with the US Forces and diligently worked your way to

designation of Sergeant. I am sorry your only brother has fallen victim to the demon drugs of the street that claim so many souls. Your decision to work with the Pense Progress I feel will provide the neutral comfort you seek as we are truly a proven confidant in such situations. Like you, we also enjoy telling our stories of the past that have impacted us and this open line of communication I feel will only benefit the both of us. Your business savvy and work ethic is evident and I commend you for making the most of your time in Afghanistan which must have been such a horrific experience considering your line of work. Seizing a business opportunity while you were not on the clock as a US Forces Sqt. shows a motivated focus towards success. I assume by this you must be in the US Air Force "Semper Paratus-Always Ready" and not in the Navy "Semper Fidelis-Always Faithful". From your upbringing I can understand why you needed to look out for yourself and why you can't trust your family including "Uncle Sam". I have donated blood three times and am familiar with the Red Cross. I also heard of the UN through an article I read about the girl in the Harry Potter movies. These were both wise and trusted sources to use to help secretly move your 9.3 million dollars out of Afghanistan. I am grateful for you reaching out to me and trusting me to secure your box of money. I will not let you down, I will not come in between you and your destiny, nor will I betray your confidence. I find it only fair to make you aware that I may soon face criminal charges or face imprisonment for taxes linked to my Social Insurance Number. I am now receiving call up to 3 times a week regarding this, so I feel they could be closing in on me any second. Given your situation I would be more than willing to help you, but given my tax situation -we should arrange to do this sooner than later.

MORRISON, Norman February 12, 1924 - November 23, 2020

The family of Norman Morrison is saddened to announce his passing on Monday, November 23rd, 2020. He was 96 years old. Norm is survived by his devoted wife of 71 years, Genevieve; daughter Shane Kurschenska (Daryl); daughter Karen Fisher (Randy); son Jeffrey (Susan); two grandchildren, Michael and Jonathan (Des); great granddaughter Maya and numerous nieces and nephews. He was predeceased by his parents James and Margaret Morrison; eldest son Glen; his sisters Evelyn McGillivary (Don) and Hazel Dey (Duke).

Norman was born in Regina and raised in Regina and on the family farm in the Cottonwood District of Pense, Saskatchewan. He joined the Royal Canadian Air Force in 1942 and served four years overseas in Britain, France, India, Myanmar (Burma) and Germany. He remained in the RCAF through late 1946 as a Flight Lieutenant Officer with his final assignment being with the RCAF and Allied Forces serving the Nuremburg Trials.

He returned home to the family farm and operated it with his father and uncles and later expanded it with his eldest son. With the support of Gen, this is where he found his greatest challenges, long hours of work with family and community. Norm and Gen resided in Regina until 2013 until they relocated to New Westminster, BC.

Special thanks to the Staff of the Primary and Specialized Seniors Clinic in New Westminster and the ER, Ward 5 South/Palliative Care teams at Royal Columbian Hospital in New Westminster, all who supported Norman and his family during his final journey.

In respect of Norman's stated wishes and adhering to existing Covid-19 restrictions, there will not be a formal service held at the present time but an informal reception will be held in Regina at a later date.


