

BYLAW NO. 1/2025

A BYLAW TO AMEND BYLAW NO. 2/2023 KNOWN AS THE ZONING BYLAW UNDER SUBSECTION 46(3) OF THE PLANNING AND DEVELOPMENT ACT, 2007.

The Council of the Town of Pense in the Province of Saskatchewan enacts Bylaw No. 1/2025 as follows:

1. <u>Future Urban Development District – FUD, subsection 5.5.5 Single Detached Dwellings</u> is amended by adding the following immediately after e):

"f) Side Yard Setback (Min) 1.2 m except: the side yard setback shall be 0 m between adjoining units, and 3.0: 0 m from the property line which follows a common or party wall. Setbacks vary to provincial highways depending on the highway classification and should be confirmed with the Ministry of Highways."

2. Residential District R1 – Section 5.6.3 Site Development Regulations Table Duplex or Semi-Detached <u>Dwellings</u> is amended by adding the following to:

Minimum side yard: "except the side yard setback shall be 0 m between adjoining units."

3. Residential Multiple Dwellings District – R2 Section 5.8.3 Site Development Regulations Table Duplex or Semi-Detached Dwellings is amended by adding the following to:

Minimum side yard: "except the side yard setback shall be 0 m between adjoining units."

4. Residential Multiple Dwellings District – R2 Section 5.8.3 Site Development Regulations Table Townhouse or Row House is amended by adding the following to:

Minimum side yard: "except the side yard setback shall be 0 m between adjoining units."

5. Residential Multiple Dwellings District – R2 Section 5.8.3 Site Development Regulations Table Triplex or Four-plex is amend by adding the following to:

Minimum side yard: "except the side yard setback shall be 0 m between adjoining units."

- 6. <u>That 5.13 Consolidated Tables of Zoning Requirement Regulations tables</u> is amended by adding the following to the following tables:
 - 5.13.10 Minimum Side Yard M [FT] Not Abutting A Public Street

Column R2, Duplex Dwelling, Semi-Detached Dwelling Unit, Townhouse, Triplex/Fourplex - except the side yard setback shall be 0 m between adjoining units

5.13.11 Minimum Side Yard M [FT] Not Abutting A Public Street

Column R2, Duplex Dwelling, Semi-Detached Dwelling Unit, Townhouse, Triplex/Fourplex – except the side yard setback shall be 0 m between adjoining units



That this Bylaw shall come into force and take effect upon the date it is adopted by Council.
