

## **BYLAW NO 6/2025**

## A BYLAW TO AMEND BYLAW 23/2013 A BYLAW TO REGULATE THE OPERATION AND PARKING OF VEHICLES AND THE USE OF THE HIGHWAYS

The Council of the Town of Pense in the Province of Saskatchewan enacts as follows:

That Bylaw No.23/2013 respecting the operation and parking of vehicles and the use of highways is amended as follows:

- 1. by adding the following to Appendix 1 "stop streets":
  - 29. Brunswick Street (Northbound) to stop at Qu'Appelle Street
  - 30. Brunswick Street (Southbound) to stop at Qu'Appelle Street
  - 31. Qu'Appelle Street (Eastbound) to stop at Brunswick Street
  - 32. Qu'Appelle Street (Westbound) to stop at Brunswick Street
  - 33. Lewis Street (Northbound) to stop at Qu'Appelle Street
  - 34. Lewis Street (Southbound) to stop at Qu'Appelle Street
  - 35. Qu'Appelle Street (Eastbound) to stop at Lewis Street
  - 36. Qu'Appelle Street (Westbound) to stop at Lewis Street
  - 37. Press Street (Eastbound) to stop at Elder Street
  - 38. Press Street (Westbound) to stop at Elder Street
  - 39. Elder Street (Northbound) to stop at Press Street
  - 40. Elder Street (Southbound) to stop at Press Street
  - 41. Press Street (Eastbound) to stop at Lewis Street
  - 42. Press Street (Westbound) to stop at Lewis Street
  - 43. Lewis Street (Northbound) to stop at Press Street
  - 44. Lewis Street (Southbound) to stop at Press Street
  - 45. North Front Street (Eastbound) to stop at Lewis Street
  - 46. North Front Street (Westbound) to stop at Lewis Street
  - 47. Lewis Street (Southbound) to stop at North Front Street
  - 48. North Front Street (Eastbound) to stop at Brunswick Street
  - 49. North Front Street (Westbound) to stop at Brunswick Street
  - 50. Brunswick Street (Southbound) to stop at North Front Street
- 2. By repealing Appendix 2 "Yield Streets ".
- 3. That this Bylaw shall come into force and take effect upon the date it is adopted.
